The Ministry has advised that Odgers Berndtson was contracted to conduct a nation-wide search for a qualified individual that the Audit Council could recommend to the Minister as the Auditor General for Local Government. The search conducted by Odgers Berndtson resulted in several candidates being interviewed, including the successful candidate, Basia Ruta. The money paid to Odgers under their contract included the travel and related costs for all candidates to be interviewed by the Audit Council.
