I am writing further to your request received by the Ministry of Environment (the Ministry).
Your request was for:

All records, reports, documents, agreements, emails, land title submissions and survey plans/documents with regards to the Providence (Marshall) Lake Dam, DL 1705 (Timer Fractional) owned by Richard Gottselig and DL 901 (New York) owned by Kettle River Resources Ltd. Date range is January 1, 2010 to January 8, 2014.

Further to the Ministry's response to your request, you requested that the Office of the Information and Privacy Commissioner (OIPC) review the decision to withhold certain information pursuant to section 22 of FOIPPA. As a result of the ongoing mediation efforts with the OIPC, the Ministry has reconsidered its decision to withhold information pursuant to section 22 and is now providing the enclosed records to you in their entirety.
