Re: Request for Access to Records – Fee Estimate Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Health. Your request is for:

Copies of records setting out the amounts paid (or records permitting such amounts to be calculated in the event that records setting out the amounts are unavailable) by the provincial health insurance plan to hospitals, health facilities, preferred providers for mental health and addiction services including services for the treatment of eating disorders and drug and alcohol dependency, rendered to insured persons while outside of Canada, in the absence of an emergency (ie on a pre-approval basis) in the aggregate (per year) and per patient (average); Copies of records setting out the number of insured persons referred (including patients referred and not approved, and patients referred and approved) for the out-of-country mental health and addiction services referred to above (or records permitting such amounts to be calculated in the event that records setting out the number are unavailable). Date range is January 1, 2009 to May 1 2013.
