Determination of Fee Waiver

INTRODUCTION:

Section 75 of the Freedom of Information and Protection of Privacy Act (the Act) permits the head of a public body to charge fees for specific services associated with requests for information made under section 5. These fees do not apply to requests for personal information.

It is government policy that fees should be charged under the Act in order to allow a public body to recover a portion of the costs of processing a request. However, this policy is not a substitution for reviewing section 75(5) to determine if it is applicable to the request.

Section 75(5) states:

- (5) If the head of a public body receives an applicant's written request to be excused from paying all or part of the fees for services, the head may excuse the applicant if, in the head's opinion,
 - (a) the applicant cannot afford the payment or for any other reason it is fair to excuse payment, or
 - (b) the record relates to a matter of public interest, including the environment or public health or safety.

PART 1: SUMMARY OF APPLICANT'S REASON(S) FOR REQUESTING A FEE WAIVER

The applicant requests a fee waiver on the grounds that the records relate to matters of public interest, and the applicant notes an inability to pay. The applicant's argument is quoted below:

"This fee estimate is both unreasonable and excessive. It is a clear strategy by your office to quash my request.

I qualify for a fee waiver as I am a member of the media, with limited funds, reporting in the public interest. I have the ability to widely and freely disseminate the information, to increase public understanding of how spending and policy is decided by elected and appointed officials.

Simultaneous to this fee waiver request, I call on you to provide me substantial and mutually beneficial advice on how I can narrow the request to avoid a fee."

Determination of Fee Waiver

INTRODUCTION:

Section 75 of the Freedom of Information and Protection of Privacy Act (the Act) permits the head of a public body to charge fees for specific services associated with requests for information made under section 5. These fees do not apply to requests for personal information.

It is government policy that fees should be charged under the Act in order to allow a public body to recover a portion of the costs of processing a request. However, this policy is not a substitution for reviewing section 75(5) to determine if it is applicable to the request.

Section 75(5) states:

- (5) If the head of a public body receives an applicant's written request to be excused from paying all or part of the fees for services, the head may excuse the applicant if, in the head's opinion,
 - (a) the applicant cannot afford the payment or for any other reason it is fair to excuse payment, or
 - (b) the record relates to a matter of public interest, including the environment or public health or safety.

PART 1: SUMMARY OF APPLICANT'S REASON(S) FOR REQUESTING A FEE WAIVER

The applicant requests a fee waiver on the grounds that the records relate to matters of public interest, and the applicant notes an inability to pay. The applicant's argument is quoted below:

"This fee estimate is both unreasonable and excessive. It is a clear strategy by your office to quash my request.

I qualify for a fee waiver as I am a member of the media, with limited funds, reporting in the public interest. I have the ability to widely and freely disseminate the information, to increase public understanding of how spending and policy is decided by elected and appointed officials.

Simultaneous to this fee waiver request, I call on you to provide me substantial and mutually beneficial advice on how I can narrow the request to avoid a fee."
