Further, only a small portion of TNO records fall under FOIPPA, including transcripts of media scrums and speeches prepared by government employees. The majority of TNO records consist of a variety of media formats which are available for purchase by the public through various media outlets, and therefore are not within the scope of the Act, see Section 3(1)(j).
