As post-secondary education falls within the responsibility of the Honourable Amrik Virk, Minister of Advanced Education, your e-mail has been forwarded to me for response on the Minister's behalf.

While the Ministry of Advanced Education provides funding for British Columbia's public post secondary institutions, these institutions operate under provincial legislation, including the College and Institute Act and the University Act, which provides that the governing bodies of the institutions have jurisdiction over all matters relating to the management and administration of the institutions. Under the University Act, s.22 has the responsibility for program policies, including dispute resolution. Consequently, Government does not intervene in these matters.

In your e-mail, you reference the Ombudsperson. It is not clear whether this is a reference to the Ombudsperson at s.22 or the provincial Ombudsperson. Individuals who have exhausted all internal appeal processes at a public post-secondary institution and who believe that a resolution of their concerns has not been reached may wish to contact the British Columbia Office of the Ombudsperson. The Office of the Ombudsperson receives inquiries and complaints about the practices and services provided by public agencies. While not an advocate, the Ombudsperson can conduct impartial and confidential investigations to determine if a public agency is being fair to the people it serves. I commend your commitment to furthering your education, and acknowledge your disappointment that your program has not qualified you for employment with some employers. As you are likely aware, individual employers develop their own hiring practises and policies.

While the Province of British Columbia is responsible for the legislation that governs private career training in British Columbia, it does not directly oversee private career training institutions such as \$.22 These institutions are regulated by the Private Training Institutions Agency (PCTIA), a Crown agency s.22 created by the Province under the authority of the Private Career Training Institutions Act.

Typically, for PCTIA to investigate a student complaint regarding an institution, the complaint must be made within six months of the incident occurring. As you have indicated that the incidents you experienced at this exceeds the six month period for filing a complaint.
