Any and all compliance audits, reviews and reports by the Gaming Policy and Enforcement Branch of 50/50 raffle draws conducted at Canadian Football League games in Vancouver (including BC Lions pre-season, regular season and playoff games at BC Place Stadium) during the 2012 calendar year and any correspondence to and from the BC Lions and their 50/50 contractors for the period of January 1, 2012 to [February 8, 2013] and for the National Hockey League games in Vancouver (including Vancouver Canucks pre-season, regular season and playoff games at Rogers Arena) from April 1, 2011 to [February 8, 2013], including any correspondence to and from Canucks Sports and Entertainment and their 50/50 contractors.

Please find enclosed the Fifth and Final Phase of your request. Some information has been withheld in the enclosed records pursuant to sections 15 (Disclosure harmful to law enforcement), 17 (Disclosure harmful to the financial or economic interests of a public body), and 22 (Disclosure harmful to personal privacy) of FOIPPA.
