## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Energy, Mines and Natural Gas (Housing). You narrowed your request on October 12, 2012 through conversation with Alan Hughes.

Your original request is for any and all records related to the cancellation of the negotiated request for proposal process for the privatization of liquor distribution, including any bid submissions, business case, briefing notes or decision notes.

You agreed to IAO providing links to our Open Information website identifying releases that would answer portions of the request. In addition, you were particularly interested in the NRFP submissions and records related to the selection of proponents during the  $2^{nd}$  stage of the NRFP process and subsequent cancellation.
