“Copy of any records or incidents reports, regarding the incident at the Kamloops Regional Correctional Centre in which someone breached the perimeter fence and drilled through a cell window in what was believed to be a delivery of contraband to the inmates. The date range is July 7, 2013 to August 11, 2013.”
