It's not that long ago, there were no ramped curbs at intersections in B.C.

For most of us, it's just a small step. Easy to take for granted.

A barrier that took away their independence. But then things changed – because people with disabilities raised their collective voice.

Their voices were heard. You'd be hard-pressed to find an intersection without ramped curbs in just about any community in B.C.

So, just how much more difficult is it for a person living with a disability to face and overcome challenges most people take for granted?

A lot more – probably more than most British Columbians can imagine.

That's why we made a commitment to make B.C. the most advanced province in the country for persons with disabilities.

But government cannot accomplish that alone.

There are 550,000 people living with disabilities in B.C...

...And we need them, we need you, and we need other British Columbians to share their experiences and their ideas.

To find ways we can work together to reduce barriers and improve accessibility.

Because whether you're someone living with a disability... or a friend, family member, neighbour, employer or coworker...

Everyone has a role to play. Everyone has a role in helping persons with disabilities fully participate in our communities.

That's why for three months, we held a comprehensive public consultation.

And as a result, we now know a lot more than ever before about how people live and learn – and the challenges they face.

So today, I'm very excited to unveil Accessibility 2024, our government's 10-year Action Plan that responds to the voices of those thousands of British Columbians.

Over the next ten years, making progress each and every year, culminating in the year 2024, we intend to lead the country in accessibility by achieving these 12 goals:

- The most inclusive government in Canada.
- The most accessible services in Canada.
- The best Internet access.
- The most accessible building code.
- The most accessible housing options.
- The most accessible communities.
- The most accessible transportation options.
- The most responsive disability assistance program.
- The best labour participation rate for persons with disabilities.

- The highest savings rate for persons with disabilities.
- Emergency Response Plans that include and incorporate the needs of persons with disabilities.
- And finally, to be recognized as a premier accessible travel destination with the best goods and service delivery for both our citizens living in B.C. and those travelling to B.C.

This is more than a plan – it's a commitment.

One shared by government, businesses, and communities throughout B.C.

A commitment to lead the way, and push back against challenges, prejudices, and barriers.

And while there's a lot of work to do, we can take the first steps right here and now.

That starts with appointing Linda Larson as the Parliamentary Secretary on Accessibility.

Linda will work closely with persons with disabilities, with business and non-profit sectors to develop inclusive

practises and provide direction to a new B.C. Accessibility Secretariat we are launching this fall.

Second, we will look for options for a made-in-BC approach to legislation to improve access for persons with disabilities – without causing financial pressures and without creating extra red tape.

And it's important to note – we're not starting from scratch here. Some businesses have already shown they're willing to step up and build creative solutions for accessibility.

Minister McRae introduced you to the Presidents Group this morning – a group of firmly committed CEOs ready to lead the way.

To improve access to jobs and goods and services for persons with disability.

We have municipal leaders here today ready to move forward to make communities more welcoming and inclusive.

We have inspirational leaders such as Rick Hansen and Carla Qualatrough who have opened doors and inspired people around the world.

We have much to be proud of in B.C. that we can build on.

Next, people receiving long-term disability assistance have told us we need a system that recognizes their long-term need beyond the monthly, return-to-work-based income assistance system.

What they want – and what they deserve – is greater dignity and respect.

So we will look for ways to separate the two sides of the system in a respectful way that recognizes and balances the needs of those needing short-term support to return to work and those who need longer-term support.

Fourth, we are going to help create more employment opportunities for persons with disabilities.

And we're going to do that by providing greater support for people want to work – and by helping businesses improve supports:

- We will provide \$3 million per year for assistive technologies that support employment goals...
- \$1.5 million for training in trades, technical or high labour demand programs...
- And \$1 million per year for labour market research, into increasing employment opportunities for persons with disabilities.

This is in addition to the 85 WorkBC Employment Centres throughout the province that deliver specialized employment-related services for persons with disabilities right now.

Finally, we are committing \$2 million in one-time funding for the University of Victoria's CanAssist program.

If you haven't heard of CanAssist, they're doing great things. They're dedicated to helping people with disabilities improve quality of life, and promoting independence and inclusion.

Their team develops innovative technologies and programs where there are gaps in existing services. I'm looking forward to seeing what they come up with next.

We have a lot of work to do to make Accessibility 2024 a reality. But it starts with these first steps.

If we continue to share ideas... If we continue to consult and listen to the voices...

And if we continue to work together in an atmosphere of trust, mutual respect and partnership, we will reach our goal of being the most progressive place in Canada for persons with disabilities.

We will make a better B.C.
