The total cost of the conservation office and forestry to watch caribou closures for snowmobilers in the whole Cariboo region including costs of helicopters, fuel, snowmobile rentals, transportation plus wages and also including how much is spent to collar, study and move the Caribou annually. Timeframe from July 2011 to July 2012.
