## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice and Attorney General (the Ministry). On September 26, 2012 you narrowed your request. Your request is for:

- 1. Any <u>statistics</u> on incidents of inmate-on-inmate violence and inmate-on-staff violence in BC Correctional facilities on a year-by-year basis from January 1, 2007 to September 6, 2012 for the following institutions: Fraser Regional Correctional Centre in Maple Ridge, Kamloops Regional Correctional Centre, Prince George Regional Correctional Centre, Vancouver Island Regional Correctional Centre in Saanich, North Fraser Pretrial Centre in Port Coquitlam, Surrey Pretrial Services Centre, Alouette Correctional Centre for Women, Ford Mountain Correctional Centre and Nanaimo Correctional Centre;
- 2. a) Specific details on the: August 12, 2012 beating of [named individual] at North Fraser Pre-trial, April 3, 2012 death of [named individual] at North Fraser, April 3, 2012 death of [named individual], 69, in North Fraser: and
  - b) the March 15, 2012 and March 17, 2012 fights between Hells Angels and other ganglinked inmates at North Fraser;
- 3. Any reports, briefing notes or other documents on issues related to gang members and gang associates in provincial jails <u>from 2009 to the present</u>."
