Incident Details

At approximately 21:35hrs, there was some commotion and shouting heard from the 2nd tier in the vicinity of cells 20 -16. Officer Mondin and myself looked up from behind the unit desk and observed I/M s.15, s.22 walking quickly away from s.15. Shortly thereafter I/M s.15, s.22 came out of s.15 appearing to be in distress. Officer Mondin called a code yellow because an altercation had clearly taken place. While the unit was being locked down by responding officers, officer Mondin and myself secured I/M s.15, s.22, who was then handed over to Sierra 3 Bahia, along with officers Athwal, and Shokar and escorted down to Seg. After a quick search of nearby cells on the 2nd tier, I/M s.15, s.22 was found in his s.15, s.22 attempting to wash blood off of his face. I/M was then taken in s.15 to Seg by officers D.Anderson and Perry. After reviewing the s.15 it was realized that I/M s.15, s.22 and I/M s.15, s.22 were also involved behind the scenes. These two inmates were also escorted to Seg individually by officers M.Jones and Sierra 2 Vanstaalduinen. This concludes my involvement in this incident.

I responded and saw that CO Athwal had placed inmate s.15, s.22 in s.15 on the second tier. I approached the two of them and asked what happened. CO Athwal stated that s.15, s.22 was identified as one of the participants in what was believed to be a fight. At this point, CO Athwal, CO Shokar, and I escorted inmate s.15, s.22 to SEG and s.15, s.22 Inmate s.15, s.22 was assessed by the nurse. He claimed to have s.15, s.22 An injury report was completed, as was an incident release form. s.15, s.22

Through further investigation, it was determined that there was a physical altercation of some sort between inmates s.15, s.22 Inmate s.15, s.22 during this incident and was taken off s.15, s.22 He has since returned and is pending charges in SEG. An injury report was completed as was the incident release form. Inmate s.15, s.22 It should be noted that inmate s.15, s.22 is also pending charges in SEG.

Incident Details

On 12.03.15, on the Bravo West living unit, at approximately 2240hrs, there was a Code Yellow called due to an inmate physical altercation in and around s.15. I, CO Mondin was working the Bravo Pod Prowl position, Bravo 2. I was seated behind the unit desk with the Living Unit Officer, SO Osei-Owusu. We stopped our conversation when we heard some banging and other noise. An inmate then exited s.15 quickly and it looked that a struggle was occurring. I called a Code Yellow on the portable radio and myself and SO Osei-Owusu ordered the unit to lockdown or enter the yard. The unit was locked down and secured by the responding officers. I went to s.15 and found blood droplets on the floor. s.15 was empty except for inmate s.15, s.22 s.15, s.22 lying on the bottom bunk. I placed him in s.15 and checked him for injuries or signs of fighting. s.15, s.22 claimed he was not involved and the evidence supported this. I released him from s.15 and he returned to his bottom bunk. I observed that inmate s.15, s.22 had injuries on his face consistent with fighting, redness and scratches. Upon reviewing the s.15 of the incident, CS Vanstaalduinen determined that inmate s.15, s.22 had been acting as a lookout in front of s.22 and had closed the door twice while a fight between s.15, s.22 and s.15, s.22 occurred. I helped escort s.15, s.22 to Segregation and that concluded my involvement in the incident.

Once the unit was completely locked down it was determined from unit and responding staff that a physical altercation had occurred between inmate s.15, s.22 and inmate s.15, s.22 inside of s.15 while inmate s.15, s.22 kept watch. It was later determined that inmate s.15, s.22 may have had some involvement in the incident as well. At approximately 2200 hrs this officer, along with CS Vanstaaldien and A/CS Anderson escorted inmate s.15, s.22 from his cell in s.15, s.22 down to s.15, s.22 and he was placed in the s.15, s.22 holding tank. I returned to my regular duties as Bravo One where i finished off my shift. This concluded my involvement in the incident.
