I am writing further to your request received by the Ministry of Jobs, Tourism and Skills Training (Labour). You narrowed your request on August 27, 2013 through our conversations and emails. Your request is for:

A copy of the contract pertaining to the services provided by Wazuku Advisory Group Inc in the 2012-2013 fiscal year that resulted in the government payment of \$55,300 to the Wazuku Advisory Group Inc, as per the Public Accounts 2012/13. Date range is April 1, 2012 to March 31, 2013.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. A copy of this section of FOIPPA is provided for your reference. A complete copy of FOIPPA is available online at:

The Ministry has also advised that the payments totalling \$55,300.00 were made in April 2013, and that the payments from April 1, 2012 to March 31, 2013 were for \$20,160.00. As the payment amounts from April 1, 2012 to March 31, 2013 were under the \$25,000 threshold for reporting purposes, these payments are not shown under the "other supplier payments" section of the 2012/13 public accounts.
