## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Finance. You narrowed your request on September 23, 2013 through conversation and/or email with Cheryl FitzSimons. Your request is for:

À copy of the original agreement between Tourism Vancouver and the Ministry of Finance, signed in 2003, which sets out Tourism Vancouver's obligations to contribute \$90 million towards construction costs of the expanded BC Convention Centre; A copy of the most recent version of that agreement; What changes or alterations have been made to the agreement; Total payments that have been made; Records from Provincial Treasury; Timeframe is January 1, 2003 to July 24, 2013.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section 13 (Policy advice or recommendations) of FOIPPA. A copy of this section of FOIPPA is provided for your reference. A complete copy of FOIPPA is available online at:

Please note some information in the records is marked 'not responsive' as it does not respond to the wording and/or the date range of your request. Your file is now closed.

The Ministry has advised that items in green shown on the excel spreadsheet show the contribution payments by Tourism Vancouver through July. The Province agreed to pay Tourism Vancouver's contribution payments for Fiscal Year 2013; this is shown by the orange items on the spread sheet. As a result, if the province's payments (highlighted in orange) are included as payments attributed to Tourism Vancouver, then Tourism Vancouver would have paid \$5,874,396. If the Provincial payments on behalf of Tourism Vancouver are excluded, then Tourism Vancouver would have paid \$4,597,112 in contribution payments. The total debt outstanding for Tourism Vancouver is \$108,380,284.54 through July 2013.
