Any and all documents and communications relating to hosting agreement between British Columbia and the Times Group as referenced in the January 22, 2013 government news release. This search may be confined to the Minister and Deputy Minister's offices, CLIFF and any specific individual directly responsible for or involved with the hosting agreement; Estimates of the economic benefits associated with the Times of India Film Awards; Spending approvals for 9.5 million in matching funding to the Times Group and 1.5 million for various activities in B.C. including hosting the BC-India Global Business Forum; The cost of the Vancouver press conference held January 22, 2013, including any and all travel expenses.
