Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

The oversize load permit for a mobile home issued around Sept 2011 which would have been valid Sept 6 - 10, 2011 issued to The Home Boy's company of Spokane, WA; any citations issued to this company for violations from 2011 to October 31, 2012.

Please find enclosed a copy of the records located in response to first portion of your request, i.e. "The oversize load permit for a mobile home issued around Sept 2011 which would have been valid Sept 6 - 10, 2011 issued to The Home Boy's company of Spokane, WA." These records are provided to you in their entirety.

Per your telephone discussion with Jennifer Finnegan of our office, additional records that respond to the second half of your request, i.e. "any citations issued to this company for violations from 2011 to October 31, 2012" have resulted in a fee estimate. I am advised that you indicated your intention to withdraw this portion of your request. Please confirm by email to Jennifer your intention in this regard.

In addition, further to your conversation with Jennifer last week, the Ministry of Transportation and Infrastructure has indicated that the Insurance Corporation of British Columbia (ICBC) may also have responsive records on violations and citations.
