I am writing to inform you about changes in the delivery of Youth Custody Services (YCS) and to ask that you please share this information with the justices, judges and other judicial officers of your courts.

The Minister for Children and Family Development is today announcing the decision to close the Victoria Youth Custody Centre. The specific time-lines around the closure will be announced in the next few weeks.

After much consideration of options, and in the face of both declining funding and increasingly low numbers of youth in custody, a decision has been made to implement the following changes:

- The Victoria Youth Custody Services Centre will be closed and all youth custody services will be delivered at the Burnaby and Prince George Youth Custody Services Centres
- Keeping with best practices, services for female youth will remain centralized at Burnaby Youth Custody Services.

The new provincial capacity level will be set which will provide sufficient staffed capacity to respond any possible count fluctuations.

YCS is currently staffed for a provincial capacity of 132 youth. During the 2013-14 fiscal year there was an average daily population of 74 youth leaving 58 unoccupied but staffed bed spaces on any given day. This compares to an average daily population of 220 in 2002/2003.

Under-utilization has progressively increased, particularly over the past two years. Despite the closure of four custody centres between 2003 and 2005 and other reductions, including those made as recently as 2012, the youth custody system has been consistently under-utilized. Similar declines in custody counts have been noted in many other jurisdictions across Canada.

We are shifting services to two custody centres and ensuring that programs and services follow best practice approaches.

The following remains a priority:

- Continued development and implementation of enhanced programs addressing the specific needs of youth in custody (e.g., trauma informed practices, addictions and mental health services, programs for Aboriginal male youth in Prince George, and gender specific programs for females in Burnaby).
- Strengthening of the community engagement strategy including family visitation programs through both the increased use of technology to facilitate contact with families and communities, and some financial assistance to families for on-site family visits and reintegration leave supports as appropriate.
- Support for youth when returning to their home community upon release from custody.

The effect of this change once complete will mean that youth in Victoria on pre-court detention, short periods of remand or those who are serving short sentences will be held in police lock-up. This practice is consistent with the current experience of other communities throughout the province where youth are not directly proximate to a custody facility.

We anticipate an orderly transfer of youth from the Victoria Custody Centre to the Burnaby Custody Centre and that the change will not be fully implemented before summer.

In transferring youth during this period, we will use a combination of custody staff and the BC Sheriff Services dependent on circumstances, which is the current practice elsewhere in the province. About 50-60% of youth at Victoria Youth Custody Centre are from the Victoria area, the rest being from other communities on the island or elsewhere in the province. Once the closures have been fully realized and transfers of youth currently in custody completed, the BC Sheriff Services will affect future transfers.

If you have any questions regarding these changes, please contact me directly. I would also be please to meet with you or other members of your courts to discuss this, or indeed any other issue related to youth custody matters, further at your discretion.



Youth Under age 18 in Custody Active-In Count (Total) vs. Capacity



General Police comments without attribution:

It was stated that the Keep of Prisoners Agreement may need to be re-opened because is out of date.

Will police have standards for youth in detention imposed on them if they are forced to house youth in cells?

Victoria Police Department comments:

Jamie Graham's statement that VicPD is "not in the business of holding kids" was reiterated. Then why have police been involved in the discussion about closing the facility so late in the day?

The liability is the biggest piece of the equation for having these youth in police cells. Further, their Police Board needs to know and they might say "no" to even contemplating police cells might be an option even in extreme circumstances for these youth. There needs to be some type of agreement in place to frame the circumstances in which possible youth detention in police cells might occur. Police cells are not built for kids – Cells are small, there are no showers, no exercise facilities, no windows, lights stay on 24/7, cells are noisy, open to other adults in lock up, they hand out "A & W meals", – no place for kids in trouble.

VicPD indicated that they would be bringing this issue to the attention of their board for their discussion at their May 14th Board Meeting. Area chiefs would be discussing the issue as well.

Summary of Police Issues related to housing youth in detention in police cells:

- 1. Liability
- 2. Fee Schedule
- 3. Protocols to ensure police are the last resort, not the first.

Lisa's notes

Police comments (in addition to what has been noted above):

Not happy about being notified at such a late stage. Feels this is a ministry issue and not a police issue. No plan, no consultation, no risk management. Question about contingencies if labour unrest. This is not a negotiation. Costs to government to house the youth in police cells needs to be high enough to make government notice — can't make it too easy for them. 




VYCS Sentenced vs. Remand FYTD 2013/2014






VYCS Average Length of Stay Days




Aboriginal Youth in Custody Percentage




Average Number of Youth In Custody vs. Centre Capacity



Average Counts of Youth in Custody by Province FY2011/2012




Per Capita Rates of Youth in Custody by Province 2011/2012





Per Capita Violent Youth Crime Rates by Province 2012




Per Capita Total Youth Crime Rates by Province 2012

PURPOSE: For INFORMATION for Suzanne Anton, Attorney General

and Minister of Justice

ISSUE: Closure of the Victoria Youth Custody Centre.

SUMMARY:

• The Ministry of Children and Family Development (MCFD) has announced the closure of the Victoria Youth Custody Centre (VYCC).

- The closure of the VYCC may result in an increased need for use of police cells in the Greater Victoria region for youth on pre-court detention or short-term remand status.
- Discussions are continuing, lead by MCFD, with Ministry staff and Victoria area
 police to ensure that the needs of police are considered in the process of moving
 to a new operating model for male youth affected by the closure.

BACKGROUND:

- On April 28, 2014 MCFD announced the closure of the youth detention centre in Victoria due to the declining number of youth in custody. The date of closure has not yet been confirmed, however, it is anticipated to close in late June or early July 2014.
- There has been an approximate 65 per cent decline of youth in custody over the
 last decade in BC. The average youth custody count was 220 in 2003 and the
 average youth custody count in the last fiscal year was 74. In general, in the
 past year, BC's three youth custody centres have been operating at an average
 capacity of 56 per cent.
- The Victoria Youth Custody Centre (VYCC), which has the capacity to house 60 youth had an average count of 15 youth in custody through 2013. From January to March 2014, the average count declined to 11.
- The closure of VYCC will assist MCFD to offset a loss of almost \$4.5 million in annual federal funding for youth justice services, however, MCFD has indicated that this is an operational decision and would have been made regardless of the loss of federal funding.
- Once the centre is closed, Greater Victoria youth who would have previously been housed at VYCC will instead be transported to the Burnaby Youth Custody Centre (BYCC) pending their next court appearance (on remand status) or to

serve their sentence.

- In the absence of a youth custody centre in the Greater Victoria area, MCFD will be dependent on police to house youth as follows:
 - Pending transport to BYCC following the initial court appearance/tele-bail hearing when the youth has been remanded in custody.
 - Overnight on the night before a scheduled court appearance for remanded male youth (same day travel is currently only available through the Sheriff Services for female youth) or nightly for trials that run over consecutive days.
 - To serve short sentences (ie. if a youth received a two-day sentence, it
 would likely not be feasible to transport the youth to BYCC on the day of
 sentencing only to be returned to the Greater Victoria area by MCFD staff
 the following day for release).
- The Executive Director of Youth Justice and Forensic Services met with the
 Assistant Deputy Minister of Police Services on April 17, 2014 to advise of the
 pending closure. A meeting with the chief constables from the Victoria and
 Saanich police departments and the RCMP's Island District was held on
 April 28, 2014; at the same time that the closure was being announced publicly.
- A further meeting which included Youth Justice & Forensic Services, Police Services, the Assistant Deputy Minister for Court Services, the chief sheriff, the deputy chief constables from both Saanich and Victoria Police departments and a representative from Westshore RCMP was held on May 14, 2014.
- Saanich and Victoria police departments have taken a position that they will not house 'provincial' youth prisoners.

I am writing to inform you about changes in the delivery of Youth Custody Services (YCS) and to ask that you please share this information with your staff.

The Minister for Children and Family Development has announced the decision to close the Victoria Youth Custody Centre. The specific time-lines around the closure will be announced in the next few weeks.

After much consideration of options, and in the face of both declining funding and increasingly low numbers of youth in custody, a decision has been made to implement the following changes:

- The Victoria Youth Custody Services Centre will be closed and all youth custody services will be delivered at the Burnaby and Prince George Youth Custody Services Centres
- Keeping with best practices, services for female youth will remain centralized at Burnaby Youth Custody Services.

The new provincial capacity level will be set which will provide sufficient staffed capacity to respond any possible count fluctuations.

YCS is currently staffed for a provincial capacity of 132 youth. During the 2013-14 fiscal year there was an average daily population of 74 youth leaving 58 unoccupied but staffed bed spaces on any given day. This compares to an average daily population of 220 in 2002/2003.

Under-utilization has progressively increased, particularly over the past two years. Despite the closure of four custody centres between 2003 and 2005 and other reductions, including those made as recently as 2012, the youth custody system has been consistently under-utilized. Similar declines in custody counts have been noted in many other jurisdictions across Canada.

We are shifting services to two custody centres and ensuring that programs and services follow best practice approaches.

The following remains a priority:

- Continued development and implementation of enhanced programs addressing the specific needs of youth in custody (e.g., trauma informed practices, addictions and mental health services, programs for Aboriginal male youth in Prince George, and gender specific programs for females in Burnaby).
- Strengthening of the community engagement strategy including family visitation programs through both the increased use of technology to facilitate contact with families and communities, and some financial assistance to families for on-site family visits and reintegration leave supports as appropriate.
- Support for youth when returning to their home community upon release from custody.

We anticipate an orderly transfer of youth from the Victoria Custody Centre to the Burnaby Custody Centre and that the change will not be fully implemented before summer.

In transferring youth during this period, we will use a combination of custody staff and the BC Sheriff Services dependent on circumstances, which is the current practice elsewhere in the province. About 50-60% of youth at Victoria Youth Custody Centre are from the Victoria area, the rest being from other communities on the island or elsewhere in the province. Once the closures have been fully realized and transfers of youth currently in custody completed, the BC Sheriff Services will effect future transfers.

YCS is currently staffed for a provincial capacity of 132 youth. During the 2013-14 fiscal year there was an average daily population of 74 youth leaving 58 unoccupied but staffed bed spaces on any given day. This compares to an average daily population of 220 in 2002/2003.

Under-utilization has progressively increased, particularly over the past two years. Despite the closure of four custody centres between 2003 and 2005 and other reductions, including those made as recently as 2012, the youth custody system has been consistently under-utilized. Similar declines in custody counts have been noted in many other jurisdictions across Canada.

We are shifting services to two custody centres and ensuring that programs and services follow best practice approaches.

The following remains a priority:

- Continued development and implementation of enhanced programs addressing the specific needs of youth in custody (e.g., trauma informed practices, addictions and mental health services, programs for Aboriginal male youth in Prince George, and gender specific programs for females in Burnaby).
- Strengthening of the community engagement strategy including family visitation
 programs through both the increased use of technology to facilitate contact with
 families and communities, and some financial assistance to families for on-site
 family visits and reintegration leave supports as appropriate.
- Support for youth when returning to their home community upon release from custody.

The effect of this change once complete will mean that youth in Victoria on pre-court detention, short periods of remand or those who are serving short sentences will be held in police lock-up. This practice is consistent with the current experience of other communities throughout the province where youth are not directly proximate to a custody facility.

We anticipate an orderly transfer of youth from the Victoria Custody Centre to the Burnaby Custody Centre and that the change will not be fully implemented before summer.

In transferring youth during this period, we will use a combination of custody staff and the BC Sheriff Services dependent on circumstances, which is the current practice elsewhere in the province. About 50-60% of youth at Victoria Youth Custody Centre are from the Victoria area, the rest being from other communities on the island or elsewhere in the province. Once the closures have been fully realized and transfers of youth currently in custody completed, the BC Sheriff Services will affect future transfers.
