Any records, dated January 1, 2011 to July 24, 2012 related to Rio Tinto Alcan's request under the Industrial Development Act and sections 9 and 18(d) of the Water Act to authorize construction of the partially completed second Kemano tunnel and to amend the 1950 agreement to include the completed second tunnel as authorized works under the amended Final Water Licence 102324; The plan attached and marked as Exhibit A to the Conditional Water Licence no. 19847 issued December 29, 1950.
