I am writing further to your request received by the Ministry of Health. Your request is for:

- Official government documents (formal final documents e.g., those which have gone to the Legislative Assembly or Cabinet, briefing notes, feasibility study, survey report, etc.) that discuss how much money will be saved by implementing the secure health cards (new care card) and how they will help to reduce fraud; and
- Any other general information (other documentation that you might have created such as backgrounder, project description document, etc.) about the fraud and financial aspects of the introduction/implementation of the new care card.
