This includes any FOI training manuals, presentation materials, notes, written rules or advice about how staff is supposed to conduct themselves when it comes to FOI. For clarification by OIC political staffers, I am referring to GCPE communications staff, MA's, EA's, and other OIC staff hired for jobs in GCPE shops, the Premier's office and Ministerial offices. There is no date range for the request, but I would like the most up to date materials used in this form of training."
