Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice and Attorney General.
Your request is for:

1. Policy Manuals, including changes, additions or deletions to those Manuals, for the Intervention Program;
2. Number of drivers who received an Administrative Driving Prohibition and
 - who were required to enroll in the Responsible Driver Program
 - and in the Ignition Interlock Program by the Office of Superintendent of Motor Vehicles
3. Number of drivers who received an Administrative Driving Prohibition who were NOT required to enroll
 - in the Responsible Driver Program and
 - in the Ignition Interlock Program
4. Number of drivers who received an Administrative Driving Prohibition who had no previous driving prohibition of any kind on their driving record before being required
 - to enroll in the Responsible Driver Program and
 - the Ignition Interlock Program by the Office of Superintendent of Motor Vehicles;
5. Number of drivers who received an Administrative Driving Prohibition who had other driving prohibitions (Administrative, 24 hour or Immediate Roadside Prohibitions included) in addition to the Administrative Driving Prohibition the driver received immediately before being required to enroll in the Responsible Driver Program and the Ignition Interlock Program;
6. Number of drivers who were required to do the Responsible Driver Program and the Ignition Interlock Program for any other reason that was not a driving prohibition.
