I am writing further to your request received by the Ministry of Environment. Your request is for:

All documents and correspondence between the Province and Canada, the Province and Semiahmoo First Nation, internally or other in respect to Peace Arch Park land transfer and use excluding records that deal with use of the park by the public; Any documents and correspondence related to the use of Semiahmoo Indian Reserve lands by BC Parks. Time frame is January 1, 1900 to January 1, 2009.

Please find enclosed a copy of the records located in response to your request.
