Copy of permits to transport live trout and stock Minnie and Stoney Lakes, to raise water levels in Minnie and Stoney Lakes, to divert water from Quilchena Creek into Minnie and Stoney Lakes, to screen Wasley Creek to stop fish from spawning, to do work in and around Walsey Creek at the bridge by Minnie Lake, to fish commercially in Minnie or Stoney Lake.
