A list of any and all individuals who accompanied the Premier on her May 2012 Trade Mission to Japan, Korea and the Philippines; A detailed itinerary for the Premier as well as for anyone accompanying or working with the Premier during the trip and mission; A summary of all expenses and taxpayer costs incurred by the BC government for this trip/trade mission, including an indication as to whether these are the total costs or whether there are still outstanding receipts for any participant; Any special instructions provided regarding trade mission accommodations and events.
