Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

Relating to a motor vehicle accident on March 22, 2007 on Highway 97 just north of Beaton Park Road near Charlie Lake: the contact between the Ministry and the company that was responsible for maintaining the highway on March 22, 2007; Documentation relating to when the company was first notified about the condition of the highway prior to the collision and when the highway was last salted or sanded prior to the collision; Any other documentation that is relevant to this matter.

As you were advised on September 22, 2014, the Ministry does not have any records regarding a motor vehicle accident on March 22, 2007 at the location indicated in your request. Enclosed please find a copy of the records located in response to your request for “*when the highway was last salted or sanded prior to the collision; Any other documentation that is relevant to this matter*”.
