I wanted to provide some background and an update on a recent IRP judicial review decision reported in the media this week.

The media reports follow a Supreme Court of BC judicial review decision made by the Hon Justice Dley in the case of Wilson v. British Columbia (Superintendent of Motor Vehicles). A copy of the decision is attached and is also available at www.courts.gov.bc.ca/jdb-txt/SC/13/16/2013BCSC1638.htm. In this Judicial Review, the judge quashed an IRP review decision made by OSMV and set the notice aside.

The Province today filed an appeal of this judgement to the BC Court of Appeal. Although the filing of the appeal does not stay the decision in this case, the decision did not strike down the IRP legislation. Therefore, the law remains in place and the Superintendent will continue to conduct administrative reviews of IRP's in accordance with the applicable law and legislation.

I apologize for the delay in sending out this message, however I wanted to be in a position to confirm our response to this decision directly with you.
