Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Health. Your request is for:

Regarding the BC Smoking Cessation Program which began in September 2011: The cost (whether in-house or contracted) of developing and implementing the program, after the June 2011 announcement and before the program start, split by STOB and whether in-house or contracted; Monthly data on the costs of the program, separating administrative and overhead costs (whether in-house or contracted) from product costs with admin/overhead costs by STOB and whether in-house or contracted and product costs split by each smoking cessation medication or nicotine replacement product; The number of clients of the program and monthly data on the number of new enrolments, split by which smoking cessation medication or nicotine replacement product the patient chose and indicate/split repeat clients; The number of deaths and hospitalizations for clients of the program and monthly data, going back to 2009, split by which smoking cessation medication or nicotine replacement product the patient used and indicating whether the death or hospitalization took place before using the product (for hospitalizations only), while using the product, or after completing the course of the product. Date range is January 1, 2009 to [July 15, 2013].

Please find enclosed a copy of the records located in response to your request. Please note some information in the records is marked 'not responsive' as it does not respond to the wording and/or the date range of your request, the remainder of the records are provided to you in their entirety.

This type of research projects would take several months to complete by one or more of ministry analysts. As a result of this, there is no obligation for the Ministry to create a record, in accordance with s. 6 (duty to assist) of the Act.
