CORE Teleconference Minutes

September 26, 2012, 9:00 – 10:00 am

1. OSMV Updates

a. Update from MOC

- Some agencies are faxing multiple batches (files) in 1 fax. The problem then arises with page numbers if the file goes forward for review and a lawyer is involved. Disclosure being faxed to the lawyer indicates that all pages have not been received. **One file, one fax** please.
- ASD Documentation – Some officers are faxing in ASD Documentation other than the Certificate of Calibrator.
- Old IRP's are still being served and seem to be coming in from all over, no specific detachments.
- Mention was made that the clerks at the detachments/departments would not necessarily be aware of what documents are required by the OSMV. If police wish, they could create a checklist for their clerks that could be posted by the fax machine. That would assist them in knowing what to fax to the OSMV.

b. Update from Appeals Registry

- Some issues when requesting documents.
- In the event of a file going for review, the documents are required as soon as possible.
- OSMV can only request the documents once, we cannot send out a further request as a reminder.

c. Update from Adjudications

- Revocations for IRP's are generally falling under the umbrella of appellants questioning the ASD.
- This may be due to clerical errors or officers not including certificates with their reports.
- Significant scrutiny is being placed on the Certificates of Calibrator.

2. Police Liaison Information Updates:

- Over 1900 IRP's issued in July.
- 1231 Fails and 646 Warns.
- Provincially, 13% of all IRP's were appealed. 16% were revoked on appeal.
- 31% less IRP's issued in 2012 (1956 IRP's) compared to July 2011 (2833 IRP's).
- There are many variables as to what has caused this decrease, possibly a pattern will form as time goes on.
- Report for August will be coming out soon.
- Core email address anticipated to be operational soon.

3. Discussion Items:

a. Road Safety Project

- Monday, October 22, 2012, there will be a meeting in Surrey on the Road Safety project. The meeting will last for approximately 5 hours. The project will be explained as to how it will work and the business processes will be identified. If more information is required, please let Daffydd Hermann know.
- BCACP – There will be information and an overview on the Road Safety project.

b. Reports From Policy and Research Branch

- Advised that a quick check has August looking like there is a decrease in IRP's from August 2011.

4. Enforcement Roundtable:

a. Comments from members

- High Risk interlock violations – email should be sent to police liaison so a high risk violation report can be done on the individual.
- Concern about acknowledgment when high risk forms for interlock & medical are being sent to OSMV. Members would like confirmation that the documents have been received and are being processed.
 - For follow up.

5. Reminders:

- Please ensure that VI's for **category B** – Section 251 MVA (behavioural: prohib, excessive speed, UL/VI, etc) are sent in a timely fashion so as to be properly entered into a driver's record. This will ensure that the proper upgrade occurs for any subsequent offence in category B (30 days for a second offence in category B).
- In a situation where a driver has committed an offence for category A (alcohol IRP) and category B (behavioural: prohib, excessive speed, UL/VI, etc), please select the appropriate boxes in **BOTH** categories. This will ensure that the proper upgrade occurs for any subsequent offence in category B (30 days for a second offence in category B).
