## MINISTRY OF EDUCATION KEY RESPONSIBILTIES AND OPPORTUNITIES NOTE COWICHAN VALLEY OFFICIAL TRUSTEE 2013

#### **TOPIC DESCRIPTION:**

Cabinet appointed an official trustee to the Cowichan Valley School District in 2012. A decision is required concerning whether the official trustee should be left in place until the next local government election in 2014.

#### **BACKGROUND:**

- In July 2012, Cabinet removed the Board of Education for Cowichan Valley School District after it failed to adopt a balanced budget, as it was required to do under the School Act.
- Cabinet appointed the Superintendent from Surrey School District, Mike McKay, as the official trustee to govern the district in place of the Board. The official trustee has all the powers and duties of a board of education. Without further action by Cabinet, the official trustee would be replaced by a newly elected board of education at the next local government election in November 2014.
- In 2012, the Minister committed to holding elections a year earlier, in November 2013. Under the *School Act*, Cabinet has the authority to remove the official trustee and either order elections in the district or appoint trustees to hold office until the next local government election.

30	The Official Languages in Education Protocol (OLEP)  The Protocol is a multi-year, multilateral agreement between the federal government, through the Department of Canadian Heritage and the Council of Ministers of Education, Canada (CMEC), which acts on behalf of all provinces and territories. The Protocol sets the main parameters for collaboration between Canadian Heritage and the provincial/territorial ministers of education in the area of official languages in education.  The current Protocol expired in March 2013. The Province received over \$64.4M under this four-year Protocol. Negotiations for the renewal of a Protocol started this spring.  The Protocol governs the negotiation of bilateral cost-sharing agreements between provinces/territories and the Government of Canada. Once the Protocol has been signed, B.C. will be in a position to negotiate and conclude a bilateral agreement with the federal Department of Canadian Heritage for the disbursement of federal funds.
