Thank you for your June 23, 2012 email addressed to Honourable Rich Coleman, Minister of Energy and Mines, regarding power supply for Liquefied Natural Gas (LNG) facilities being proposed on British Columbia's north coast.

Consistent with the Premier Christy Clark's announcement in June 2012, LNG export facilities, and the electricity generation used to power them, are now excluded from the *Clean Energy Act*'s 93 percent cleanest renewable energy requirement.

This change will ensure the LNG industry can access a reliable, timely and cost-competitive mix of gas-fired and renewable power generation to meet its large electrical demand. This is an improvement, from a greenhouse gas emissions perspective, of the usual industry practice of using natural gas direct drives for the liquefaction process. The 93 percent clean energy target will continue to apply to non-LNG load and ensure the majority of British Columbia's power requirements will be met with renewable resources.

The Province will have world-class air emissions standards for gas-fired power generation to support LNG plants. This policy will apply to both high-efficiency combined cycle gas generation and simple single cycle peaker plants, where they may be required, and guide both BC Hydro procurement and environmental reviews. All infrastructure built will be subject to British Columbia's environmental assessment process.
