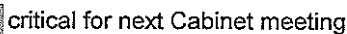

Issue:

- **Ministry of Health 2012/13 Annual Service Plan Report**

Background:

- The "2012/13 Annual Service Plan Report", required under the *Budget Transparency and Accountability Act*, will be tabled with Public Accounts in late June or early July.
- The report is a high level comparison of actual results for the year with the expected results that were identified in the "Ministry of Health 2012/13 – 2014/15 Service Plan." It will be sent through standard review procedures, including review and approval by Ministry Executive and Government Communications and Public Engagement before being sent to the Minister of Health for review and signature.

Decision required:

- **This is a 30 day issue.**
- The Ministry of Health 2012/13 Annual Service Plan Report will require ministerial signature in late June to be tabled with Public Accounts.
