Relating to Highway 5 on November 20, 2010; all records relating to the activation of all alerts displayed on dynamic message signs prohibiting vehicles that were not equipped with chains, winter tires or sanding devices from being driven or operated between the District of Hope and Kamloops; information or documents confirming that the Clapperton chain-up area was the nearest designated chain-up area going northbound to North Surrey Lake and confirming the location of the nearest designated chain-up area north of North Surrey Lake.
