Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Finance. You narrowed your request on September 29, 2014 through conversation and/or email with the Ministry. Your request is for:

A record, for the previous fiscal year (April 1, 2013 to March 31, 2014), listing all service contracts across government awarded to RLD Strategies, including the name of the public body contracting the service, and the value of the contract; A record listing what public bodies RLD Strategies is contracted to do work for in this fiscal year (April 1, 2014 to [August 1, 2014]).
