## Dear Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Children and Family Development. Your request is for:

Any statistics on incidents of inmate-on-inmate violence and inmate-on-staff violence on a yearby-year basis from January 1, 2009 to [November 9, 2012] for the following facilities: Burnaby Youth Custody Services, Prince George Youth Custody Services and Victoria Youth Custody Services; and patient-on-patient violence and patient-on-staff violence for the same period for the Maples Adolescent Treatment Services Centre.

Your request asks for statistics showing annual breakdowns of incidents patient-on-patient & patient-on-staff violence at four youth custody facilities. The Ministry wishes to advise these records do not exist. Additionally, pursuant to section 6 of FOIPPA, creating a record would unreasonably interfere with the operations of the Ministry. However the Ministry is able to provide two reports, one for Maples Adolescent Treatment Services Centre which includes data up to November 30, 2012 and one which includes figures for the three remaining youth custody facilities up to November 9, 2012.

The Ministry advises for the purpose of the report, the term "violence" includes several different types as listed on the reports. These reports are provided to you in their entirety.
