I am writing further to your request received by the Ministry of Justice. Your request is for:

Relating to 1321 Marine Drive, West Vancouver, BC Date of Fire Loss October 28, 2012 at 10:00 pm: All Fire Department and Fire Investigator communication records, incident reports, journal entries, field notes, diagrams, witness statements and dispatch information pertaining to the Premium Custom Design Cabinets & Millwork Fire; Copies of all photographs and videography, both digital and film that pertains to this incident; Fire prevention and inspection reports including any notice of violation issued for this property in the previous two years prior to the fire.

On October 7, 2014, your Assistant, Maggie Janus, was contacted and advised that no fire report exists for the location provided in your request. However, a fire report was located for a fire that occurred on the same day at a nearby location, 1337 Marine Drive, and Maggie confirmed that this is the report you wish to receive.
