### **Temporary Parental Educational Support**

What is the purpose of the temporary parental educational support that you are announcing? Is it for child care costs?

The temporary support is intended to help parents offset the costs of alternative learning activities. It is usually families with younger children who face the biggest disruptions -- that's why this is targeted to those with children in Kindergarten to Grade 7, as well as any children under the age of 13 in higher grades. For example, if the strike went on for a few weeks in September, some parents might feel it necessary to look for a tutor for their child. While it is not specifically targeted for child care we know that finding child care will be a significant challenge for many parents.

Over the summer, it is quite common to see young children enrolled in themed day-camps, or arts programs, or soccer camps while their parents are at work. By providing communities and local organizations with sufficient notice, we hope that they might be able to extend some programing into the fall in the event of a strike. Combined with the temporary parental educational support, we hope that can generate more options for parents to keep their children engaged in learning activities than would otherwise be the case.

It's unlikely that local groups will be able to offer the same range of programs as over the summer months – but with advance planning they might be able to do a lot more than if it were left until September.

# Where do the funds come from for the temporary parental educational support and how much will this cost B.C. taxpayers?

The funds will come from the Province's strike savings should a strike continue into the fall and students are prevented from attending classes.

## Will the savings from an ongoing disruption all be allocated to support parents?

Our intent is to utilize strike savings in support of parents should a strike continue into the fall.

## How much would parents really benefit from this temporary educational support payment?

We do not expect that the temporary parental educational support would be able to fully cover child care or any other cost that parents could incur because of the strike. Child care is only one of many impacts. A strike affects families many different ways, so we do not want to be overly prescriptive and we need to make the assistance administration as simple as possible. To add a number of additional requirements or conditions would only increase administrative costs while delaying the payment of the assistance to the parents who need it.

This is a temporary educational support payment for parents only; it is not intended to replace the benefits of the education system. The support amount is limited by the amount of strike saving that are available.

# How would the temporary and one-time parental educational support payment work?

s.13 parents of public school students in Kindergarten to Grade 7, as well as any children under the age of 13 in higher grades, would be able to apply online for the B.C. temporary parental educational support, expected to be up to \$40 per eligible child for each lost day of school.

This means that a qualifying family with two eligible children could potentially receive up to \$400 per week in temporary parental educational support. If a strike lasted three weeks that amount could reach up to \$1200.

Further details on temporary parental educational support will be available in September.

# How will parents receive information on the parental educational support and learning resources?

A one-stop website will be launched to provide B.C. parents with information about temporary parental educational support, learning resources and other up-to-date information.

It would be nice if we could leverage the Federal baby bonus program or whatever it is called these days. For now I will respond to the theoretical case where MoEd does the supplier number and invoice piece after receiving an electronic list of payees (sin, address, name, payment amount...etc.). This I know with 100% certainty - it will not be easy.

Assume that CGI will be comfortable and commit to the estimates below.

Ecas – Not a good fit. Each payment needs a contract. Ecas is designed for low 100s of payments not thousands or 100s of thousands of payments.

Pass – Not a good fit. Each payment heavily linked to a stamp; complicated invoice processing would need to be mimicked.

Trax – Best chance, of the 3 systems. Easy to work in technical environment without complicated implementation processes.
