In accordance with information received in this office, our records have been updated to indicate that you are the appurtenant landowner of Lot 1 Section 15 Township 22 Rnage 20 Kamloops Division Yale District Plan 22024 (PID 007-125-551). Attached is a copy of your licence for your records. The licence authorizes the diversion and use of 4.0 acre-feet to irrigate an area measuring 2.0 acres as well as a permit for your works to cross 0.26 acres of Crown Land. For your information the name on the licence document does not get updated, only our computer records do.

Water licenses, and the rights and obligations granted therewith, are appurtenant to land, mine, or undertaking and pass with the conveyance or other disposition of the land to any new owner. A right granted with a water licence is the priority for the use of water related to the date the application was made for the original licence.

One of the obligations is the payment of annual rentals and fees to the Crown for the authorization to exercise the rights granted under the licence. At this time the yearly rate is \$22.00 for irrigation rights and \$6.00 (plus \$0.42 GST) for the Permit Over Crown Land; the next statement for three years rentals will be created in 2007.

Please be advised that although the licence is in your name any subdivision and sale of any part of the appurtenant land may give any new owner the right to part of that licence.

I just received a phone call from Carol Holt s.22 • cecive a bill for more than \$300 for a licence that she says she abandoned in 1998 or 1999 when she first bought the place.

She sent a letter back then explaining that there was no spring, and they didn't want the license for a spring that was no longer useable. She also filled out the Change of Property form on the back.

I don't have Region 3 files here to check, although, I am presuming that she sent her letter to the PO Box which would have gone to Victoria anyway, so I don't think those things get forwarded to the regions, but maybe I'm wrong about that.

She said point-blank that she refuses to fill out the form again because she already did it. I asked her about the bills and she said she has been getting them every year and threw them out, but now that it's getting bigger, and because she sold the place in June, she thought she would try again to get it dealt with.

I have no idea what we can do in a situation like this. She was adamant that she already contacted us in 1998 or 1999. The billings on her file didn't start until 2000 so theoretically, she should never have received a bill.

I know how a client can be frustrated in dealing with government, but I am also confused as to why she would throw out the bills instead of addressing them if she felt she was being billed in error.

Please let me know what the procedure is in a case like this. While it is out of my region, I have received a couple of calls of this nature for my own region and so the answer would be helpful for me.



Previous applications have been made on the source under 0309330, 0366263 and 3001337. Application 0309330, made on November 29, 1971, was recommended granted for 500 gad and the unnamed spring was named Rick Spring. The application was later cancelled for non-completion. The sketch for the report dated November 21, 1973, shows Rick Spring in the same location as the source for application 3003108. Application 0366263, made on March 31, 1980, was recommended refused for 500 gad. Although the the RER dated January 7, 1982, on file 0366263 states: "I believe this to be Rick Spring (see cancelled file 0309330)", the letter of refusal refers to "Venture Spring (formerly unnamed)". This was in error. Application 3001337, made on August 10, 1988, refers to the source as Venture Spring, although the inspection report refers to "Venture (Rick) Spring". This again was in error as the location of the source for application 3001337 is in the same location as the spring for applications 0309330, 0366263 and 3003108. Application 3001337 was later abandoned. The source for all these applications is therefore Rick Spring and there is no Venture Spring.

Application 0366263 was refused as "Venture Spring" is a tributary of Tranquille River and Tranquille River is fully recorded. The RER for 0366263 states that "Venture Spring" sinks or may be tributary to Cecil Spring which sinks. Thus the letter dated December 10, 1984, is incorrect as Rick Spring is not tributary to the Tranquille River.

4. Additional Hydrologic Information:

The flow observations of 1-3 gpm on August 8, 1973, and no visible flow on May 29, 1981, are taken from file 0366263. The comments on the source in this file state that the source is a damp area which has the potential to be developed into a domestic source. These observations were probably made before the source had been developed, as observations on the source in 1991 and 1997 measured flows of 8.9 gpm and 7.0 gpm respectively. The demand for this application of 4 acre-feet is 6.2 gpm based on 120-day irrigation season. Flow measurments show that this flow appears to be available. It is recommended that the application be granted.







I just received a phone call from Carol Holt service a bill for more than \$300 for a licence that she says she abandoned in 1998 or 1999 when she first bought the place.

She sent a letter back then explaining that there was no spring, and they didn't want the license for a spring that was no longer useable. She also filled out the Change of Property form on the back.

I don't have Region 3 files here to check, although, I am presuming that she sent her letter to the PO Box which would have gone to Victoria anyway, so I don't think those things get forwarded to the regions, but maybe I'm wrong about that.

She said point-blank that she refuses to fill out the form again because she already did it. I asked her about the bills and she said she has been getting them every year and threw them out, but now that it's getting bigger, and because she sold the place in June, she thought she would try again to get it dealt with.

I have no idea what we can do in a situation like this. She was adamant that she already contacted us in 1998 or 1999. The billings on her file didn't start until 2000 so theoretically, she should never have received a bill.

I know how a client can be frustrated in dealing with government, but I am also confused as to why she would throw out the bills instead of addressing them if she felt she was being billed in error.

Please let me know what the procedure is in a case like this. While it is out of my region, I have received a couple of calls of this nature for my own region and so the answer would be helpful for me.

#### B. TECHNICAL REPORT ON: **Rick Spring**

i. General Comments:

The source is a spring which surfaces in a wetted area, flows on the surface for a short distance and goes underground. There was no sign of any channel below where the flow goes underground. Previous applications have been made on the source under 0309330, 0366263 and 3001337. Application 0309330, made on November 29, 1971, was recommended granted for 500 gad and the unnamed spring was named Rick Spring. The application was later cancelled for non-completion. The sketch for the report dated November 21, 1973, shows Rick Spring in the same location as the source for application 3003108. Application 0366263, made on March 31, 1980, was recommended refused for 500 gad. Although the the RER dated January 7, 1982, on file 0366263 states: "I believe this to be Rick Spring (see cancelled file 0309330)", the letter of refusal refers to "Venture Spring (formerly unnamed)". This was in error. Application 3001337, made on August 10, 1988, refers to the source as Venture Spring, although the inspection report refers to "Venture (Rick) Spring". This again was in error as the location of the source for application 3001337 is in the same location as the spring for applications 0309330, 0366263 and 3003108. Application 3001337 was later abandoned. The source for all these applications is therefore Rick Spring and there is no Venture Spring.

Application 0366263 was refused as "Venture Spring" is a tributary of Tranquille River and Tranquille River is fully recorded. The RER for 0366263 states that "Venture Spring" sinks or may be tributary to Cecil Spring which sinks. Thus the letter dated December 10, 1984, is incorrect as Rick Spring is not tributary to the Tranquille River.

4. Additional Hydrologic Information:

The flow observations of 1-3 gpm on August 8, 1973, and no visible flow on May 29, 1981, are taken from file 0366263. The comments on the source in this file state that the source is a damp area which has the potential to be developed into a domestic source. These observations were probably made before the source had been developed, as observations on the source in 1991 and 1997 measured flows of 8.9 gpm and 7.0 gpm respectively. The demand for this application of 4 acre-feet is 6.2 gpm based on 120-day irrigation season. Flow measurments show that this flow appears to be available. It is recommended that the application be granted.






