The proposed amendments will bring into force *Child, Family and Community Service Act* amendments passed in 2011, which will allow custody of a vulnerable child to be permanently transferred to his/her caregivers, in specific circumstances. The proposed amendments also outline the required contents of plans of care for children in alternatives to foster care, as per a commitment made to the Representative for Children and Youth.

Bountiful Hearing August 11, 2011 Updated Feb 7, 2012, March 26, 2012

ADVICE AND RECOMMENDED RESPONSE:

- We welcome the BC Supreme Court's decision to uphold the Criminal Code provisions regarding polygamy.
- Nothing is more important to this ministry, myself and this government than the safety and well-being of the children and youth in British Columbia.
- I am pleased that the judge's decision clearly puts the safety of women and children first.
- The Province has made a decision not to seek a second reference opinion from the B.C. Court of Appeal or Supreme Court of Canada.
- Anytime the ministry receives a complaint of alleged abuse, the ministry reviews the circumstances to determine if an investigation is required and if there is a concern regarding criminal conduct the ministry works in cooperation with police.
- If there are protection concerns, the ministry will always work to assure the safety of a child and family and community engagement is very important in this process.
- Much work has been done by members of Bountiful and by community and government service providers to ensure that there is access to services (such as transition homes and daycare) when needed and that we are openly addressing any barriers

Cross border marriages:

- The welfare and wellbeing of a child or youth is the responsibility of the child protection services agency in any relevant jurisdiction.
 The B.C. Ministry of Children and Family Development has no jurisdiction outside of its borders.
- However, if the ministry is made aware of a B.C. child or youth in another jurisdiction that may be in need of assistance, we would work with that jurisdiction to confirm that any concerns are being

addressed.

• If there are protection concerns, the ministry will always work to assure the safety of a child – and family and community engagement is very important in this process.

Texas Raid Case:

- In this case, ministry officials were in contact with child welfare officials in Texas to ensure the safety and well-being of the youth.
- The Texas authorities maintained jurisdiction of the youth until she became an adult.

KEY FACTS REGARDING THE ISSUE:

- On November 23, 2011, the B.C. Supreme Court upheld Canada's Criminal Code provisions regarding polygamy.
- The decision states youth 12 to 17 involved in polygamous unions should not be criminalized, but youth 18 and over should be subject to prosecution for acts they commit after they reach 18.
- This case was not a criminal proceeding, but a reference case on the constitutionality of Canada's current laws prohibiting polygamous marriages.
- On March 26th, 2012, the Minister of Justice and Attorney General announced that that the Province would not seek a second reference opinion from the B.C. Court of Appeal or Supreme Court of Canada.




- In May 2008, the ministry was contacted by the Foreign Affairs Department of Canada regarding the possible return of a 17 year old youth to Bountiful - this youth
- The youth was one of 400 children seized by Texas authorities in April, 2008, following a raid on the "yearning for Zion" polygamous sect. The state accused the sect of physically and sexually abusing the children.
- The youth s.22 which complicated matters for the Texas authorities who wanted to send her back to Canada.
- The ministry investigated the concerns and the child was not in need of protection at that time. The youth,
- On August 9th, 2011, Warren Jeffs, President and Prophet of the Fundamentalist Church of Jesus Christ of Latter-Day Saints (FLDS) was convicted on two counts of sexual assault of a child and sentenced to life in prison.



Issue: MCFD Budget Management Action Plan, strategies and next steps

Background: MCFD has had a flat budget since September 2009 but has continued to face growing demand from two case-driven service lines:

- Services to Children and Youth with Special Needs (CYSN):
 - Autism, Nursing and Medical Services are policy driven and have been the dominant drivers in increased costs; demand for other CYSN services also continue to grow with resulting increased wait lists.
- Child Welfare
 - Demand for child welfare services has continued to grow managed in part by increased use of extended family placements but with increased costs associated with managing more complex in-care needs
 - → Budget 2011/12 included an internal ministry reallocation of funding to Aboriginal strategies of \$5 million from within its Child Welfare budget and additional costs associated with increasing the use of Delegated Aboriginal Agencies.

Deputy Minister

Stephen Brown was appointed Deputy Minister, Ministry of Children and Family Development on March 14, 2011. 
Doug Hughes






Anne Sandbu



Issue:

The Minister of Children and Family Development is scheduled to participate in the Community Poverty Reduction Strategy Workshop at the Union of British Columbia Municipalities (UBCM) 2012 Convention.

Background:

- The UBCM 2012 Convention is being held on September 24-28 in Victoria.
- The Convention provides a valuable opportunity for UBCM delegates throughout the province to discuss local concerns with Provincial Government representatives through presentations, workshops, clinics and meetings.
- The Ministry of Children and Family Development (MCFD) is hosting a workshop on the Community Poverty reduction Strategy; a joint project on poverty reduction at the individual and community level.
- The workshop session will provide an update on the project and consider the possibility of expansion to other communities.
- The agenda for the workshop is as follows:



Issue: Decision required on the announcement of the members of the provincial Steering Committee for the Community Poverty Reduction Strategies.

Background:

- In April 2012, the Union of BC Municipalities (UBCM) and the Ministry of Children and Family Development (MCFD) jointly announced the piloting of Community Poverty Reduction Strategies in seven communities across the province: Port Hardy, New Westminster, Surrey, Kamloops, Cranbrook, Prince George and Stewart.
- During the announcement, government committed to appointing "a provincial steering committee, including representatives from provincial cabinet, the UBCM, the voluntary sector and the business community to guide the project."
- This project is intended to provide support to families and communities living in poverty by identifying and working to address barriers to leaving poverty at the community and individual levels.
- MCFD has hired part-time staff (Community Poverty Consultants) in each of the communities to work with families and communities.
- To date, in collaboration with community partners, they have completed:
 - community profiles, which provide information on the demographics of the communities and their specific strengths and challenges; and
 - o community action plans, which identify some of the barriers to people moving out of poverty in the community and set out action plans for addressing these issues.
- In late August, the Consultants began recruiting individual families to work with directly. Supported by community partners, they will work with the families to understand their individual needs, connect them with supports and to develop personalized paths out of poverty designed by families themselves.
- Once the project has been implemented in seven communities, it will be evaluated and expanded to 20 additional communities per year with the goal of having a site in all 47 local service delivery areas (service delivery areas used by the Ministries of Health and Children and Family Development) by 2014/15.
- As the project grows, measurable data and specific project outcomes will inform policy initiatives at the provincial level and provide comparable information at the individual and community levels.
- In 2009, about 100,000 children (12%) were living in BC families with net incomes below the (Low Income Cut-Off) LICO after tax. The national rate was 9.5%.
- Families below the LICO often spend at least 20 percentage points more of their net income on food, clothing and shelter than the average family.





Summary / Decision Required:

- This is a 30 day issue.
- Decision Required Government has committed to creating a provincial Steering
 Committee to guide this project. The intention is that the Steering Committee, made up of
 well-connected British Columbians from across the province, would provide advice and
 support to the project and promote its success through their networks.
- A session on the Community Poverty Reduction Strategy pilots is being hosted at the UBCM convention on September 25th. The Minister, the Representative for Children and Youth, the Deputy Minister, local mayors and councillors from the seven communities and some of the poverty consultants will be speaking about the project during this session.
- This would be an excellent opportunity to announce the members of the Steering Committee.



Issue: Release of "Taking Action on Domestic Violence in British Columbia" and development of provincial domestic violence plan.

Background:

- In March 2012, RCY released, "Honouring Kaitlynne, Max, and Cordon-Make Their Voices Heard Now", a report on three children who were killed in April 2008 by their father.
- The report recommended a need for increased coordination and collaboration across government.
- Government accepted the recommendations and acted immediately to establish a permanent Provincial Office of Domestic Violence (PODV) under the Ministry of Children and Family Development in March 2012.
- PODV was established to provide ongoing leadership and accountability for the Province's
 domestic violence policies, programs and services and ensure that they are delivered in an
 unified and effective way to strengthen supports and services to those impacted by domestic
 violence.
- PODV is tasked with responding to the RCY report and developing a comprehensive domestic violence provincial plan which will be inclusive of an Aboriginal strategy.

Summary / Decision Required:

30 day issue:

"Taking Action on Domestic Violence in British Columbia" which is a response to the RCY report, to be publicly released end of September along with a mapping report that summarises domestic violence policies, programs and services across government. This action plan will set the course towards a coordinated and strengthened approach to domestic violence in BC.

60 day issue:

• PODV is expected to present to the Select Standing Committee on Children and Youth on October 15, 2012, an update on the recommendations to the RCY report "Honouring Kaitlynne, Max and Cordon-Make Their Voices Heard Now", as well as brief the Committee on the work of PODV.

90 day issue:

 In November 2012 key partners and stakeholders will be consulted during a major consultation forum regarding the development of the comprehensive domestic violence provincial plan which will be inclusive of an Aboriginal strategy. The plan is planned for release in December 2012.





Issue: An Order in Council has been drafted to remove an exemption from title protection for social workers employed by a Health Authority under the Social Workers Regulation (SWR).

Background:

 The Ministry has publicly stated that in order to provide the best protection for the public, all individuals engaging in the practice of social work ought to be registered with the British Columbia College of Social Workers (BCCSW) or governed in other ways, for example through clear policy and standards or a delegation process as required by the Child, Family and Community Service Act (CFCSA).

Issue: An Order in Council has been prepared to permit administrative reviews of the exercise of the director's information powers.

Background:

• The director under the *Child*, *Family and Community Service Act* (CFCSA) has unique authority to disclose or withhold information, in addition to his/her powers under the *Freedom of Information and Protection of Privacy Act* (FOIPPA). This is because of the highly sensitive and confidential nature of the ministry's business.



Issue:

An Order in Council has been prepared to bring amendments to the *Child*, *Family and Community Service Act* into force and to amend the Child, Family and Community Service Regulation.

Background:

- In June 2011, amendments to the *Child*, *Family and Community Service Act* (CFCSA) were passed, which will allow custody of a vulnerable child to be permanently transferred to the caregiver with whom he/she resides without him/her having to first come into care, when it is in the child's best interests.
- This promotes stability and permanency for vulnerable children and youth.
- An Order in Council (OIC) has been prepared to bring the CFCSA amendments into force.
