Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Energy and Mines (Core Review). Your request is for:

A copy of the current permit and any permits applicable since January 2007 for the extraction of aggregates from the Fraser River in the vicinity of Mountainview Road in McBride BC, including any constraints on the extraction of the aggregates such as amounts permitted, permitted times of extraction with regard to season, river conditions, hours of the day, etc. and also any restrictions on the permitted use of the gravel such as is it for concrete manufacture only or can it be retailed for other uses. The permit may be in one of the following company names, Robson Valley Construction Ltd., RVC Ltd., or N & V Construction Ltd. Date range is January 1, 2007 to [September 25, 2013].
