Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Environment. Your request is for:

Copy of park use permit 1505; Copies of all park use permits issued to Mt. Seymour Resorts or to Sea to Sky Parks Services Ltd. which apply for use during 2013; Copies of all park use permits issued to any party in respect of Mt Seymour Provincial Park regarding the use of roadways or parking lots during 2013; Copies of all contracts or agreements between the Province of BC and either Mt Seymour Resorts or Sea to Sky Parks Services Ltd. affecting Mt Seymour Provincial Park which apply during 2013; Copies of all contracts or agreements between the Province of BC and any party in respect of Mt Seymour Provincial Park regarding activities which may affect that park's parking lots and roadways including use of construction, placement of objects or barriers, removal, addition, repair or maintenance of or around those parking lots and roadways. Date range is January 1, 2003 to August 31, 2013.
