Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. However, please note that the Office of the Premier held no responsive records with respect to the portion of your request: "copies of payment/donation/invoices/receipt regarding ... entities that contributed". Ministry of Finance and GCPE were also canvassed for this request and responded with no responsive records, and Office of the Premier was advised that this was due to the limited timeframe of the request.
