Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice and Attorney General. Your request is for:

Relating to the NFPC Ion Scanner: The manufacturers name, manufacturing documents or studies stating the accuracy of the Ion scanner methods, the 2013 Ion scanner and system maintenance reports including calibration reports; The type, make and overall costs of the NFPC Ion scanner currently used by BC Provincial Corrections.

Section 3(1)(j) of FOIPPA states that the Act does not apply to records that are available for purchase by the public. The IONSCAN 400B Operators Manual is available for purchase at the following websites:

The IONSCAN 400B features an automatic calibration procedure which by design applies corrections for minor changes in IONSCAN parameters. It is noted that the Canadian Nuclear Safety Commission (CNSC) and Smiths Detection have indicated that under new regulations, prior licences that have <sup>63</sup>Ni with less than 1000 mBq (millibecquerel) are no longer required. As such, the IONSCAN 400B model no longer has annual inspection requirements of the CNSC. Although the ION scanners are maintained and calibrated, there is no record keeping process and there are no calibration or maintenance reports. The cost of the IONSCAN 400B is \$44, 310.
