Re: BC Sheriff Service Changes

I would like to bring to your attention several changes at the BC Sheriff Service that may affect your operations and may be of interest to your officers.

As part of a grant by the Chief Herald of the Governor General's Office, the BC Sheriff Service recently obtained a new crest, badge, and flag. These devices have now been incorporated into a new wallet badge for sheriffs.

In addition, we have updated our identification cards with a new format that includes several anti forgery devices.

Finally, we have decided to adopt a new scheme for our vehicles. As our fleet is replaced over the next number of years, your officers will be seeing significantly different sheriff cars/vans/ large trucks on the road.

Please see the attached examples of all of these items.

Given recent concerns around some ex-law enforcement vehicles being obtained by known gang associates, I thought it important to let you know about these updates such that should your officers have occasion to see our new vehicles, or need to see our badges or identification, they will know what is authentic and what is not. Should there ever be a question around authenticity, your officers can also contact our Central Dispatch at (604) 927-2653 for confirmation of identification.

I would appreciate it if you could make your officers aware of these changes. Please let me know if you have any questions or need any further material from me that could help in getting this information out.

Dave attached is an estimated quote for the decal packages for our vehicles.

Current package is \$930.00

Going to option 3 blue strip there are two options one being full reflective at \$1,055.00 and one partial reflective at \$820.00. I would not recommend the full reflective as that much on the doors could in fact be a distraction to motorist and cause other safety concerns.

Going all Black vehicle the two options are full reflective \$885.00 and partial reflective at \$800.00. Either option here works as they do not have the large blue stripe that would be a concern with the above option.

So with the exception of full reflective blue there would be no cost increase in changing the decal package for the fleet.

2. EXPERIMENTAL WORK: Work performed at customer's request such as sketches, drawings, type composition, camera work, presswork and materials will be charged for at current rates.

3. SKETCHES AND PROOFS: Sketches, copy, proofs, and all preparatory work created or furnished by AMPCO GRAFIX shall remain the exclusive property of AMPCO GRAFIX and no use of same shall be made, nor may any idea obtained there-from be used, except upon compensation to be determined by AMPCO GRAFIX.

4. DRAWINGS, NEGATIVES, ETC.: Artwork, type, drawing, negatives, positives, and any other items supplied by AMPCO GRAFIX shall remain the exclusive property of AMPCO GRAFIX unless otherwise agreed in writing.

5. ALTERATIONS: Quotations are only for work according to the original specifications. If through customer's error, or change of mind, work has to be redone a second time or more, such work will carry an additional charge at current rates for work performed.

6.
