## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Public Safety and Solicitor General and closed on December 2, 2011. Your request was for:

"All records (electronic or otherwise) which contain concerns about problem gambling specifically relating to online casino gaming provided through BC Lottery Corporation's Playnow.com website, launched in July 2010, excluding any records of media reports. Date range May 1, 2010 to [October 20, 2011]."
