I am writing further to your request received by the Ministry of Energy and Mines (Core Review). Your request is for:

Any records regarding the construction of the tailings pond dam built in relation to permit number M-85 at the Hudson Bay Mine Tailings Storage Facility Dam, located near Salmo, BC southeast of the junction where Emerald Mine Road meets Highway #3 and #6, legally described as Lot A, District Lot 1236, Sublot 36, Kootenay District Plan 14234 (PID# 010-013-911); the Dam's original construction in or around 1955; any modifications to the Dam after its initial construction including the modifications in 1964, 1975 and 1977; the production of talc and the potential for tremolite (asbestos fibre) as part of the mining operations, mine tailings or present in the Tailings Storage Facility Dam. Date range is January 1, 1954 to December 31, 1997
