A full copy of the survey of 2533 Francis Street Vernon BC for the right of way from DL 1272 through DL 55, the Kal park area of Cozens Bay, completed for the Ministry by Shatzko Engineering.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. Your file is now closed.

In addition, the ministry advised: This survey of Cozen's Bay Road, from DL 1272 through DL 55, which was completed by Shatzko Engineering for MOTI, is a ground survey which reflect the attributes of the road and includes portions of the surrounding land. The survey and plan does not establish right of way. The Ministry of Transportation and Infrastructure currently does not have a right of way plan for Cozens Bay Road through Kalamalka Park.
