Departmental records concerning the use of aerial drones, UAs, UAVs or UASs (otherwise known as drones) or plans to acquire (or borrow) and use drones in the future, including requests for proposals, proposals submitted by vendors, contracts, budgets or cost allocations, policies, guidelines and manuals and the types of investigations or incidents in which the Ministry plans to use drones.
