I am writing further to your request received by the BC Public Service Agency. Your request is for:

Documents related to the selection of the following three Ministry of Health employees, hired into these positions during 2012: Barbara Walman (ADM, Pharmaceutical Services Division), Nichola Manning (ADM, Medical Services and Health Human Resources Division) and Wendy Taylor (Executive Director, Information Management and Knowledge Services) including the following documents for each hiring: The original posting, job description, qualifications requested, etc., everything a candidate would have seen, the names or job titles of the members of the selection panel, the number of applications received, the pre-screening criteria used, and de-identified results showing how candidates were selected for testing, short-listing, interviewing, etc.; including the scores of those selected or rejected at each stage; and indicating the number of applicants who passed minimum requirements and the number who passed each subsequent stage through to final selection; The interview questions and the rating guide for the questions, the reference check criteria and/or script and information on any other procedures/criteria used to make the final selection.
