Chalmers took pictures of Minor Agent's person, and identificationTook pictures of Agent Minor 34's person and identification, confirming she was under 19 years of age; photocopied ID and had minor and myself sign copy. At 6:45 minor agent entered establishment through main gates, with hockey ticket; Chalmers and Lowden wa ked around to Security entrance, entering and signing in for 6:47pm. Chalmers and Lowden arrived at the first floor (100 level) at 6:51, and met up with minor agent. At 7pm Minor agent approached a temporary vendor initially (budweiser), where the male requested ID; at 7:70pm Minor Agent approached male Hawker, where id was again requested; approaximately at 7:10pm, Minor Agent approached Mike's Hard Lemonade stand, where two females were selling liquor, but they asked for ID. At 7:12pm Minor agent approached male Hawker at gate 115. Male sold a budwiser beer to minor without requested ID. Chalmers and Lowden watched from approaximately 10 feet away, just on the otherside of the concourse. Chalmers and Lowden had direct line of sight of the minor and the transaction. After Minor agent had liquor, met up with her and wa ked to the King's Club where there were tables. Minor Agent, Lowden and Chalmers composed notes of the transaction.
